- Jim called the meeting to order at 19:03 PST in the Eureka Municipal Auditorium (Muni) Meeting Room @ 406 11^{th} St. (11th and E). Introductions were made and the log book was passed around. 24 members attended.
- Health and Welfare: We learned that Jim Shryne **AC6YV** is SK. We shared our memories of Jim and Rachael **KE6SDB** and recalled some of their many contributions to the club. We remember him fondly as a long-time member and DXer and also, with Rachael, as our Head Cook at many Field Day Sunday breakfasts. HARC members then observed a moment of silence in Jim's honor.
- <u>Secretary Report</u>: Greg Deja's **AA6GD** November minutes were reviewed. Don Nelson **WA6NBG** motioned to accept, Steve Isherwood **KK6MPV** seconded and all voted AYE.
- <u>Treasurer's Report:</u> Marcy reported the October 24th checking account balance was \$2686.48 and the November end balance was \$3006.50
- <u>Old Business:</u> Jim plans to get the club Hex-Beam with rotor project going in the spring, when the weather warms.
- New Business: **ELECTION OF OFFICERS 2018**: The officers who offered to serve for another term were Marcy as Treasurer, Dan as Secretary, and Jaye as Newsletter Editor. New candidates who either offered to stand or were nominated were Peter as President and Anthony as Vice President. Members present were polled by show of hands and all officers were approved unanimously.
- EMCOMM Report: Our very successful November 11th emergency preparedness drill had 14 radio communicators report in on 146.460 MHz. simplex. Peter was Net Control based at the club house. Dan in McKinleyville (mobile) was able to communicate with Anthony in Blue Lake (HT) at 5W. and relay the contact to Net Control. This relay experiment showed we could reach usually inaccessible Blue Lake.
 - The next **EMCOMM event** is scheduled for **Saturday, February 17, 2018**. we will populate the Eureka Courthouse and four hospitals; Mad River in Arcata, St. Joseph in Eureka, Redwood Memorial in Fortuna and Jerold Phelps Community Hospital in Redway. Mad River has 3 HAMs on staff.
 - The 146.610 MHz repeater testing pends 'til after Daylight Savings returns on March 11th. The crew is waiting for warmer weather. The repeater is ok, but the support equipment needs fixed up.
 - The Blood Bank has 40 m and 80 m antennas and may start participating in monthly check-ins.
 - Peter is looking for EMCOMM meeting topics and suggestions.

- There is some interest in getting a 220 MHz repeater.

<u>Past Event Report:</u> November Sweepstakes; Anthony reported we contacted 50 of the possible 83 sections including Alaska, Hawaii and the Virgin Islands. We made 100 contacts for 10,000 points from our club station as **W6ZZK.**

AO-91 Commissioned, Declared Open for Amateur Use!

AMSAT-NA's latest Amateur Radio CubeSat, RadFxSat (Fox-1B), now known as AO-91, has been opened for general use. AMSAT Engineering officially announced that AO-91 was ready for use at 0650 UTC on Thanksgiving Day, November 23. AMSAT VP of Engineering, Jerry Buxton, N0JY, turned over operation to Mark Hammond, N8MH, and AMSAT Operations during a contact on the AO-91 repeater during the pass over the Eastern US, AMSAT said in a bulletin.

The latest CubeSat in the Fox series was launched on November 18 from Vandenberg Air Force Base in California. Telemetry is downlinked via the DUV sub-audible telemetry stream, which can be decoded using *FoxTelem* software.

A 1U CubeSat, RadFxSat (Fox-1B) is a joint mission of AMSAT and the Institute for Space and Defense Electronics (ISDE) at Vanderbilt University. AMSAT constructed the rest of the satellite, including the spaceframe, on-board computer, and power system. The Amateur Radio package is similar to that currently on orbit on AO-85, with an uplink on 435.250 MHz (67.0 Hz CTCSS) and a downlink on 145.960 MHz. -- Thanks to AMSAT News Service

Jim called the meeting to order at 19:03 PST in the Eureka Municipal Auditorium meeting room. Members and guests present introduced themselves, and the log book was circulated. 25 members and 2 guests attended.

Health and Welfare: Nothing reported.

Secretary's Report: Draft Minutes of the October 3, 2017 minutes were reviewed. A motion for approval was made by Forrest, KI6GRU, and seconded by Dexter, AG6DA. The motion passed unanimously.

Vice-president's Report: Peter did not have a report.

EmComm Report:

The next EmComm meeting is scheduled for November 16th, 19:00 PST at the Muni. Peter reported that he attended Sky Warn (Weather Spotter) training and a flood preparedness meeting.

- o The Sky Warn training is required for the first level of ARRL disaster training certification, and Peter reported that the training was worthwhile.
- o The flood preparedness meeting was of less value due to the minimal requirement of amateur operators in flood preparedness planning. Nevertheless, Peter felt his role as an ambassador for the amateur radio community was beneficial.

Peter made available handouts for the new Humboldt Alert Emergency Notification System, a National Weather Service flier, and band plans showing the new 135 kHz and 472 kHz bands. A traffic handling exercise is scheduled for November 11th. Operators will meet on the Far West Repeater Association system, with assignments to be determined.

Treasurer's Report: Marci presented the beginning and ending balance, and cash in and out of the account for the months of September 2107 and October 2017; however, a copy was not provided to the secretary.

New Business:

Carl, KM6LIQ, is working on a new HARC website so that he can assume the duties of administrator. John, KG6MAR does not have administrator privileges for our current yahoo email group, so a plan is being formed to move the list to a new location. More information will come as we near this goal, In the mean time, we have a pretty great web site and a working email list group to use, but soon, it will get better still! Stay tuned!

Don Campbell reported that a work party visited the Mt. Pierce site repeater site on October 14th and repaired/replaced the antenna.

Peter Esko reported that HARC was well represented at the October 14 th Sustainability Fair at the Arcata Community Center.

Don Campbell said that too few operators were available for the Humboldt Redwoods Marathon on October 15th.

o Don also said that he and Dale, KF6QIB, participated in the Boy Scout Jamboree on October 21 st, and made some HF contacts, although the primary activity was on VHF affording more scouts the opportunity to get on the air.

o Don said the current Technician class is going well.

Jim, Anthony, and Don Nelson traveled to Reno for the Techno Expo, and made a stop on the way at the Hat Creek SETI site.

o Anthony presented a brief slide show of the Reno/Hat Creek trip during the meeting, in lieu of a formal program.

HARC's table at the Emergency Preparedness event at the Adorni Center on November 4th was heavily visited. Anthony remarked that HARC members were engaged in conversation throughout the event, and commented that, at future events, the Club might want to forgo operating activities in favor of conversations with visitors.

Marci announced that the Club's Christmas potluck will be held on December 8th at the club house at the Eureka Municipal Auditorium.

Dale, KF6QIB, asked for communicators for the 39 th Truckers' Parade, to he held on December 9th. Dale provided background on the parade, and said the amateur operators would be needed for about two hours.

Joe Lowe, NU6O, will present an overview of operating on the 135 kHz and 472 kHz bands on Tuesday, November 14th, 19:00 PST, at the Muni meeting place.
