Humboldt Amateur Radio Club Minutes of Meeting – July 5, 2017 Officers Present: / Peter Esko W6IES, V.P / Dan Eaton KB6DE, Secretary / Anthony Wiese KG6LHW, Events Planner and Librarian/ Jaye Inabnit KE6SLS, Newsletter Editor Pro Tem and Jim Armstrong KW6JIM, Pres.

Peter called the meeting to order at 1905 PDT in the Eureka Municipal Auditorium (Muni) Meeting Room @ 406 11th St. (11th and E).

Introductions were made and the log book was passed. 20 members attended.

Health and Welfare: Peter's wife, Marjorie, is recovering from surgery. We wish her well.

Secretary Report: Copies of the June minutes were passed out. Forrest Schafer KI6GRU motioned t0 accept the minutes as submitted and Del Freret W6KOZ, seconded. The motion was approved unanimously.

Treasurer Report: The Treasurer was absent, so we had no formal report.

### Past Event Report:

Field Day recap: The bands were poor but our club made about 100 contacts. Several local officials dropped by to chat and we good coverage of the event in the Times Standard.

- Anthony reviewed our informal Sunday meeting at field day. A list of discussion points is attached to the minutes.

- Steve Isherwood KK6MPV suggested a Winter Field Day for January 27-28 2018.

### Action Items:

Jim volunteered to purchase a "HAM RADIO WELCOME" banner (already ordered (\$66.00) we can post when we have public events.

Anthony did an oil change, added a cutoff switch and bought two new aux. gas tanks for the generator. He will need to be reimbursed \$93.29.

The military antenna tower needs 6 guy lines. Dan accepted the task of getting those ordered and Forrest motioned to approve \$300 for expenses. Peter seconded. The vote was unanimous.

Jim purchased a Signal Link box for the club. He needs to be reimbursed \$130. Bob Colburn KA6ULG made a motion, 2nd by Joyce Isherwood KJØYCE. The vote was unanimous.

Joe Lowe NU6O suggested (at Field Day) and Jay reminded us we need RFI suppression devises on the generator power supply cords. Jaye will research this.

Peter suggested Field Day be run like an Incident Command Operation. He can provide a chart for our later review.

Options to improve the floor in the new trailer are under review. Jim says the trailer Registration pends.

Future Events:

a) Anthony told us we may participate in a Lighthouse Weekend event in Trinidad Aug. 5th- 6th. Details pend to the next meeting.

b) Anthony suggested HARC Workshop meetings on the second Tuesday each month to focus on various technical subjects. July: Satellite contact demonstration and discussion (Anthony). August: JT65 or WINLINK using the Signal Link devise (Jim). September: assembling a Hex Beam antenna base plate and post (Jim and Steve). October: APRS (Jaye).

c) Peter told us of the Sustainability Fair at the Arcata Community Center on Oct. 14. We may consider attending.

d) Del will host an ELMER session Sat. July 8th, here at 10:00. He suggested we need an updated county wide repeater list noting op. frequency, location, op. status, ownership etc.

e) Jim Falls K6FWT invites interested folks to attend an antenna party at his house in Eureka on Sat. July 8th at 10:00.

#### EMCOMM Report:

a) Peter applied to the ACS Unit (the California run version of ARES) to be recognized. The only disadvantage would be we could be deployed to a different county. Peter will contact the Humboldt County Emergency Services to find out what training we need to have to participate with them instead. A new curriculum pends for their volunteers.

b) We may consider making the Trinidad Lighthouse event (Aug. 6th) a joint EMCOMM event.

c) The next EMCOMM meeting is scheduled for July 20th 19:00 – 21:30 PDT at the Muni.

New Business: None

The meeting was adjourned at 21:30 PSDT.

### CA Hands Free Law & 2-Way Radio Thank you Don ke6hec for this relay

A quick update on the CA Hands Free Law - AB 1785/CVC 23123.5.

We have been fielding a number of inquires on if Amateur Radio (2-way radio) is exempt from the updated "hands-free" law that went into effect on January 1st of this year. The language of the legislation is "all inclusive" and tends to, by default, wrap 2-way radio use into the prohibition.

Amateur licensees in the Pacific and South West Divisions of ARRL have been working on this issue. The original bill's sponsor has been contacted a number of times. The CHP command has also been contacted.

As a result, the CHP has issued a memo to its officers advising that "a radio installed and mounted in a vehicle with a wired hand microphone is not considered a wireless communications device......and therefore is not subject to enforcement under this section." That memo was issued on March 28, 2017.

More recently, the sponsoring assemblyman entered into the Assembly Journal a letter establishing the legislative intent of the law. Essentially, the letter states that common 2-way, wired radio use was not intended to be addressed by the newer hands-free law. This letter was published in the Assembly Journal on April 27, 2017.

Please note: Use of an HT would still be a violation. The radio must be mounted and the microphone be corded to the radio.

I have packaged the CHP memo and the letter to the Assembly Journal in one document. Please pass it on. Amateurs should carry copies of these documents in their vehicles to present to law enforcement officials in case they are stopped. It may, or may not, prevent them from receiving a citation.

Please remember that not all law enforcement officers will be aware of these documents, and may not follow them. Amateurs may still be cited.

I would like to hear if any Amateur is actually cited under CVC 23123.5 for using Amateur Radio.

We can all thank the past SW Div Vice Director Marty Woll N6VI, Jim Aspinwall NO1PC, Norm Lucas WB6RVR, and others behind the scenes for their valiant effort to move this clarification forward. The effort is not over, as equally ambiguous language is being promoted in the revision to the law moving through the legislature now.

Please remind everyone that they must still not use their radios in a manner that detracts from their safe operation of their vehicle. Drivers can still be cited under the very broad "distracted driving" code section.

In Past Event Report.

Any possibility that HARC would install a packet node? We have two working nodes in Curry county, BOSLEY 145.07, & BLKMND 145.05. Three other nodes that belong to the county were never installed, but we have them now and hope to get at least one installed between Gold Beach and Bandon.

If you guys had a local node on .05, we would have easy packet access between our communities. There is one packet station in Del Norte, Leonard KA7VMW, not currently active but will probably come back.

In Curry Co the radio team @ St Tim's Medical Clinic has a thc and wants to get packet active. I'll help them get up & running.

Brian W6DWY is our elder packet guy here. He & I worked together building the packet network in the early/mid 90's. Then, we had a 220 backbone to Grants Pass and good packet coverage along coastal Curry Co. Brian would burn chips for your node if you don't have anyone with a burner.

We all know packet is old, slow, & clunky, but it's still around and still working. I hate to see it disappear when it's still useful. If that's all that's working, we'll be very happy to have it. Currently, BOSLEY is having some issues. It's not hearing well. BLKMND is solid, but has very little work to do. It's the only thing running on 05 around here. I've resisted numerous proposals to switch it to 07. W/o BLKMND, we've no packet connection Hum<>Cur.
