Jim photos of EmComm trailers as examples of the type of rig we might acquire. Forest Shafer **KI6GRG** made a motion to buy a trailer for a maximum of \$3000 if the occasion arose, at the discretion of the board of directors (officers). The Humboldt Amateur Radio Club is offering a class to prepare students for the Federal Communication Commission?s Amateur Radio Technician license examination. The Technician Class license is the entry-level license for Amateur Radio. The class is free of charge and open to all members of the community.

The class will be held in the HARC Meeting Room at the Eureka Municipal Auditorium, 406 11th Street, the corner of 11th and E Streets.

The class begins at **7:00 p.m. on Monday**, March 13, 2017. The class will meet for 10 consecutive Mondays from 7:00 to 9:00 p.m.

The class will introduce radio and electronic fundamentals, tips on operating station equipment, procedures for communicating with other Hams, license and operating regulations and radio safety.

Students are encouraged to purchase the textbook used for the Class. The book is The ARRL Ham Radio License Manual 3rd Edition, available from the American Radio Relay League (ARRL) for \$29.95 plus shipping. Following the class, students will be able to become licensed Amateur Radio operators after successfully passing the FCC license test scheduled on Saturday, May 20, in the Humboldt Bay Fire Training Room on 6th Street between C and D Streets in Eureka.

## **EmComm Report March 2017**

Our latest emergency communications exercise was held Saturday, February 25 on the 2 meter band. Our goal was to practice operating in a controlled net environment, with multiple nets on different frequencies calling simultaneously, directed by the main Exercise Net control station (ExNet). All hams were welcome, and all hams are welcome at our monthly meetings as well, on the third Thursday of each month, 7:00 pm at the Eureka Muni.

The drill began at 0900 PST, with an announcement on the Far West Repeater System describing the drill and inviting all hams to participate. The drill itself began at 0939 and concluded at 1021. Stations had been asked to compose messages related to a disaster scenario, and to transmit those messages when asked by net control. As stations checked in to the ExNet, they were asked if they had traffic and

the precedence, or importance, of their message. ExNet then directed stations to the appropriate subnet, where they checked in and were asked for their traffic.

The subnet operators were kept busy copying messages, and ExNet had to figure out which frequencies would work for the subnets. For example, the Health and Welfare Net set for the 146.910 repeater wouldn't work for all the stations, so ExNet reassigned the H&W net to a simplex frequency that worked from Indianola to McKinleyville and points in between. In one case we had to relay a message using. It was fun, we had to think on our feet, and it gave us a taste of what it might be like to have to operate in a real emergency.

Thanks to the following hams who participated: KA6ULG, AA6GD, KI6GRU, KM6DFQ, WA6NBG, KB6NN, KA6DUP; also to KW6JIM and AA6GD, who ran the EOC (Emergency Operations Center) and H&W nets, respectively. KE6HEC scribed the logs for ExNet, and KB6DE helped with equipment setup and coffee. Except for ExNet, who operated from the HARC station at the Eureka Muni, everyone used their home stations.

#### Lessons learned:

- 1. Don't use a flood scenario when we're in the middle of a series of rainstorms.
- 2. Clarify in advance that we need to use current local time (not ZULU), since the reports we submit to the County should be in local time.
- 3. Once again, we can do more to reach out and include more hams.

The next EmComm activation will be Wednesday morning, March 29, 2017, when we'll activate the station at the Courthouse and call a net for Tsunami Preparedness week.

Our project to collect information and assess the condition of the County-owned radio stations is moving forward. We have ham volunteers for most of the fire, police, CSD, etc. stations from Eureka north. We need more help in the Eel River Valley and southern Humboldt.

## ARRL Weighs In on New California "Driving While Wireless" Statute

ARRL is recommending that Amateur Radio be specifically excluded from a California statute prohibiting the use of "wireless communication devices" while driving. ARRL Southwestern Division Vice Director Marty Woll, N6VI, is taking point on the effort to revise the statute, known by its legislative bill number <u>AB 1785</u>. It was signed into law last September, and it took effect on January 1, amending §23123.5 of the state's Vehicle Code.



"ARRL has received a huge volume of inquiries and complaints about this statute in particular, since its enactment," ARRL General Counsel Chris Imlay, W3KD, wrote in a letter to Woll to provide guidance in amending the California statute. "I would urge that you present this letter at any meetings you have with California State legislators on this topic, thus to bring the issues contained herein to their attention."

Imlay pointed out that the prior statute excluded Amateur Radio by definition. The new law, which completely replaced the earlier statute, never mentions Amateur Radio, but instead contains an open-

ended definition of an "electronic wireless communications device," the operation of which while driving is prohibited. According to the statute, this "includes, but is not limited to, a broadband personal communication device, a specialized mobile radio device, a handheld device or laptop computer with mobile data access, a pager, or a two-way messaging device."

"Because of the 'not limited to' language, such a device is whatever a law enforcement officer thinks might be included, and an Amateur Radio operator is not at all protected," Imlay wrote. Such a broad definition could stymie "even the most diligent law enforcement officers," who might interpret the new Vehicle Code language more broadly than intended.

"Radio amateurs have regularly used mobile two-way radio systems for the past 70 years," Imlay said. "ARRL is aware of no evidence that such operation contributes to driver inattention," he stressed. "Quite the contrary: Radio amateurs are public service-minded individuals who utilize their radio-equipped motor vehicles to assist others, and they are focused on driving in the execution of that function."

Imlay also cited a 2009 letter to ARRL from the National Safety Council stating that there was no evidence using Amateur Radio while driving is a significant risk.

"Given the necessity of unrestricted mobile Amateur Radio communications in order for the benefits of Amateur Radio to the public to continue to be realized, ARRL urges California legislators to reconsider and amend AB 1785, to more narrowly define the class of devices included in the



prohibition," or to include a specific exemption for Amateur Radio, Imlay wrote.
