HARC Might Have a New Home!

The American Red Cross has vacated their offices at 406 11th Street in Eureka and moved to McKinleyville. Since there has traditionally been a close relationship between their organization and ours, they have agreed to let the Humboldt Amateur Radio Club use their former space!

There is a large room, about 1250 sq ft, large kitchen area that are available to us as well as men's and women's restrooms. John Adams, the city carpenter has agreed to build us a radio station in one corner. It's about 15 feet across and will consist of a counter with a shelf above it. He's also willing to build some walls and a door to provide us security for our equipment. The area is large enough to accommodate the W6ZZK repeater.

John has also agreed to reroute the coax from the back room so our equipment can be all together.

The room where the repeater currently resides will be used by the Red Cross for storage. When we decide how to go about getting a HF antenna on the roof, he will help with that too.

I think this facility would work quite

well for club meetings, licensing classes, public demonstrations,

and perhaps a Saturday a month for club members to play radio, build antenna, learning to solder

coax connectors, etc etc etc.. If there are tables, I think it might work well for our holiday banquet!

I don't have all the details on the conditions of use as of yet. Parks and Recreation will have a couple of employees in offices there.

They might have small events from time to time - art for kids, that kind of thing. But they will have nothing that would interfere with our classes or meetings. I will have all of that information before the



October meeting.

If the city has it ready by then, I would like to have the October HARC meeting there. We can experience the space, and make a final decision and vote on whether we want to accept or reject

the City and Red Cross's offer for its free use.

Personally, I think this is an incredible opportunity for HARC, and we'd be foolish to turn it down. If we come up with something better in the future, we could certainly move. But as it sits now, the City of Eureka seems pleased at the idea of us being there to the point of building us walls, helping with coax and antennas, and the general willingness to make the space fit our needs. That tells me they would not be asking to leave anytime in the near future. This could be our home for years to come. I mentioned at the September meeting that it was the new home of HARC. I have not entered into any formal agreements and I realize that we need to think more about it and see, feel, and touch it before the group makes a decision.

So, I am excited to say it is POTENTIALLY the new home of HARC!

Jim called the meeting to order at 7:06 PM at the Eureka, 6th Street Fire Department meeting room.

- c) A meeting with Reg Kennedy at the U.S. Weather Service has not been scheduled.

New Business:

REALLY GREAT NEWS!!! Jim told us the Red Cross will let us share space in their old facility. Eureka City Counsel representative and HARC member, Linda Atkins **KM6CKF**, contacted Eureka city facilities person, Miles Slatery, and confirmed our use of the 12th and E Street building in Eureka. Jim contacted Eureka City maintenance person, John Glams, who can install walls to make a dedicated radio room for us. We will be able to put HF antennas on the roof, too. The room has an adjacent kitchen.

The Red Cross has agreed because they acknowledge a potential symbiotic relationship with Amateur Radio in the benefits we can provide in an emergency. The exact terms of use need to be determined. Issues of access, insurance, when we get the keys are pending. Jim would like to use the place for our October meeting. Thanks, Jim and Linda, for making this happen.

Past Event Report:

International Lighthouse Weekend August 21-22:

Anthony told us about the event he attended with Steve Isherwood **KK6MPV** at the former Coast Guard lighthouse installation up on the west side of Trinidad Head. The Coast Guard representative gave them the keys and allowed them to take Steve's truck to the site. They made 40 contacts including Cuba and a satellite. Steve used his Buddy Pole and Yaesu 817 while Anthony used his G5RVG wire hoisted at the center on a fiberglass pole, and energized with his Yaesu 817. Anthony and Steve shared some

photos. One showed a group of visitors and hams looking out from the top floor of the old light house. Steve said officials are looking into maybe opening the site to the public once a month, which would be a good opportunity for the club members to play radio from an outstanding and unusual location.

Future Events:

- a) John Olson **KG6MAR** let us know about the 3rd Annual Prairie Creek Redwood Parks One-half Marathon at on the Newton Drury Parkway on Saturday September 17th starting at 8:30 am. The race starts at the Visitor Center. Volunteers are needed and a sign-up sheet was passed.

The frequency will be 147.445MHz, but it is currently in use and not yet hooked up for ILRP. The system is in the final test phase now on 146.520, set up as a reflector, but will end up being transferred to 147.445.

Presentation: Our speaker was Wayne Shaw **K6RWA** of RWS Services in Fortuna. He answered questions about the similarities and differences between commercial radio and amateur radio. He noted there has been less use of commercial radio since the advent of cells phones and told several interesting stories about the history of commercial radio use by the local logging and trucking businesses. Wayne was a very friendly and entertaining speaker.

Right after the classes finish, there will be a Volunteer Exam for these students to earn a new F.C.C. Amateur Radio technician class license.

IRLP back online in Humboldt

Yes, finally, after so so many months, IRLP is back on the 147.445 repeater. The local node will be connected to reflector 9194 by default which links many of our formerly local hams back to Humboldt. However, anyone is welcome to use the IRLP node to call any other node if the node is not in use locally. Simply dial the hang-up command, and call the node you wish to connect to. After you

complete your QSO, please hang up the node and reconnect it to reflector 9194 again. Soon, this will be automated, but for now, we'll just do it manually. I want to thank Norman, AI6CD for taking the node for it's formal "shake down cruise" before it finds it's permanent home in down town Eureka. Also, our node number is now 7757. I think you will be amazed at the fine audio quality the new node presents us. Enjoy the new system and remember to always pause 2 seconds before transmitting while connected to other nodes or reflectors.

Amateur Radio Parity Act - (this is IMPORTANT)

Hi, all. I wasn't going to do this, hit you again with info on the Amateur Radio Parity Act, as you have already heard from the ARRL President and Pacific Division Director. But, this issue is too important to all Amateur Radio. So, I am risking your wrath for the multiple emails on this issue.

We have an opportunity to positively affect Amateur Radio for years to come. H.R. 1301, the Amateur Radio Parity Act, has unanimously passed the House of Representatives and moved on to the Senate for consideration. All you need to do is spend two minutes of your time to send an email to your two Senators supporting the Bill. By doing so, you will have helped the future of Amateur Radio by guaranteeing our ability to have an effective outdoor antenna in a deed-restricted community.

The number of people living in such communities grows exponentially each year. Often, a ham homeowner has no choice but to live in a community restricted by covenants. There are nearly 3/4 of a million licensed hams in the United States, more than ever before. But that may change if we are forced to live in a community that refuses to allow an antenna.
